- An international student in the U.S. on an I-20 may not serve as a sponsor for another student.
- Iowa Western Community College (IWCC) reserves the right to require additional financial documentation from applicants.
- All documents provided in support of the financial affidavit become the property of IWCC and cannot be returned.
